## REQUEST FOR RESEARCH PROPOSALS: LETTERS OF INTENT RAISIN ADMINISTRATIVE COMMITTEE 2026

### **Background**

The Raisin Administrative Committee (RAC) represents the California Raisin industry. The industry has supported health research on raisins in the past but not in more than a decade. Examples of prior research supported by the RAC can be found on our website ([California Raisins: Health and Nutrition Research](#)).

As the RAC re-invigorates its research program, we are seeking Letters of Intent (LOI) for 2026 funding for non-clinical/ observational studies on the following issues:

- 1. NHANES (or suitable alternative database) analysis regarding the relationship between raisin consumption and markers of cardiometabolic and cardiovascular health and disease in healthy people, and people with Type 2 diabetes.**
  - Prior NHANES analyses on raisins were conducted over a decade ago in adults and children. These analyses looked primarily at indicators of diet quality and nutrient intake. This newer analysis would:
    - Use more updated subject data
    - Look at both healthy subjects and subjects with Type 2 diabetes (T2D)
    - Assess more health/disease markers, including fasting glucose and insulin, HbA1c, OGTT data, CRP, blood pressure, self-reported CHD, MI, stroke, etc.
- 2. Menu modelling of raisins and other popular snack alternatives in an overall healthy diet**
  - Project would stress children's nutrition but might include adult diets as well
  - Study would assess overall diet quality, as well as key nutrient/shortfall nutrients in diets with raisins vs alternative snack forms
  - A least cost diet assessment with raisins and other snack forms is preferred as well

### **3. Laboratory analysis of the nutritional value of raisins, other dried fruit products, and other related food forms (e.g. grapes, berries, etc)**

- A nutritional analysis of key nutrients in raisins and other related food sources
- Analysis would also include quantification of phytonutrients and other compounds with purported antioxidant/anti-inflammatory activity (e.g., polyphenols, flavonoids).

#### **Application information**

- LOI
  - Due January 21, 2026
  - LOI is limited to 2 pages and should contain: Project Title, Principal Investigator (PI) name, email address and institution, a statement of purpose or hypothesis, summary of approach, expected outcome or importance, projected timeline and project budget
  - In addition, researcher CVs and information on relevant related research experience should also be submitted
- Final Review
  - Applicants will be notified by Jan 23, 2026 if their project is accepted for further review and if any additional information is needed
- RAC may contact applicants via email or phone for further information/ clarification regarding project details before or after LOI decisions are made

#### **Project Timing**

- RFP awards will occur during Q1 2026
- Suitable-for-journal-submission final report is expected by July 31, 2026

#### **Project Budget**

- Targeted project maximum costs are as follows:
  - NHANES = \$70,000
  - Menu Modeling = \$40,000
  - Laboratory Analysis = \$30,000
- Projects are viewed as pilot studies that may lead to larger clinical trials in the future
- Projects can provide start-up funds for young investigators, or support for highly qualified graduate students (letter of support and project oversight by experienced senior researcher required)
- Initial (20%) project down-payment will be made within 30 days after contract signing and receipt of an invoice from the PI. Interim (40%) payment will be made within 30 days after completion of research, submission of progress report and receipt of an invoice from the PI. Final (40%) payment will be made within 30 days after submission and RAC acceptance of final report and receipt of an invoice from the PI.
- Request no more than 10% institutional overhead on selected projects

- Clear, well-thought out LOI
- Relevant health research experience
- Fulfillment of all project requirements and time schedule
- Project cost
